AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO AGREEMENT WITH RICK ENGINEERING COMPANY FOR ADDITIONAL DESIGN SERVICES FOR THE 30<sup>th</sup> STREET PIPELINE REPLACEMENT PROJECT.

WHEREAS, on August 3, 2015, the City of San Diego [City] and Rick Engineering Company [Consultant] entered into an agreement [Agreement], which is on file in the Office of the City Clerk as Document Number RR-309797 to provide professional engineering design services for the Design of the 30<sup>th</sup> Street Pipeline Replacement project [Project]; and

WHEREAS, the City and Consultant have mutually agreed to extend the terms of the agreement and amend the Agreement to provide additional design and construction support services as indicated in the expanded Scope of Services for additional compensation in an amount not to exceed \$395,000, with total compensation in an amount not to exceed \$1,995,000; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized, except by ordinance adopted by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute the First Amendment to the Agreement with Rick Engineering Company for additional design and construction support services in an amount not to exceed \$395,000 for the Design of 30<sup>th</sup> Street Pipeline Replacement project, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO- 21038.

Section 2. That the Chief Financial Officer as delegated to Financial Management is

authorized to appropriate, and the City Comptroller is authorized to expend an amount not to

exceed \$395,000 from CIP S-12010, 30th Street Pipeline Replacement, Fund 700010, Water

Utility CIP, contingent upon the adoption of the applicable Appropriation Ordinance, and

contingent upon the Chief Financial Officer first furnishing a certificate certifying that the funds

necessary for expenditure are, or will be, on deposit with the City Treasurer for the purpose of

executing this amendment to the Agreement.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a

written or printed copy having been made available to the City Council and the public prior to

the day of its final passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
