AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO THE LEASE AGREEMENT WITH THE HOUSING COMMISSION FOR OFFICE SPACE FOR THE FAMILY JUSTICE CENTER AT 1122 BROADWAY (SMART CORNER BUILDING).

WHEREAS, the City of San Diego (City) entered into a Lease with the San Diego Housing Commission on February 1, 2010 for office space located at 1122 Broadway in San Diego; and

WHEREAS, this office space is used by the Family Justice Center (FJC), a program of the San Diego City Attorney's Office, which provides free services to victims of domestic and sexual abuse; and

WHEREAS, the FJC will expand its services to include services to elder abuse victims and human trafficking victims beginning in January 2019; and

WHEREAS, in light of the expansion of services, the Housing Commission agreed to waive the 6% increase in rent for the two years beginning on October 1, 2018; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to inter into a First Amendment to the Lease dated February 1, 2010 between the San Diego Housing Commission and the City of San Diego, waiving the six percent (6%) lease rate increase that was to have started on October 1, 2018, a copy of which is on file in the Office of the City Clerk as Document No. <u>00-21050</u>.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
