AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO CHANGING 5.55 ACRES LOCATED AT 6999 CLAIREMONT MESA BOULEVARD, WITHIN THE KEARNY MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE RS-1-2 ZONE TO CC-1-3 ZONE; AND REPEALING ORDINANCE NO. O-9030, ADOPTED JUNE 4, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

WHEREAS, Apex Beverage and Concession, LLC, applicant, requested a rezone of 5.55 acres located at 6999 Clairemont Mesa Boulevard, and legally described as a Portion of Lot 54, the Highlands, Map No. 284, in the Kearny Mesa Community Plan area, in the City of San Diego, California (Property), as shown on Zone Map Drawing No. B-4337 filed in the office of the City Clerk as Document No. OO
21056

, from the RS-1-2 zone to the CC-1-3 zone (Rezone No. 2221513); and

WHEREAS, on November 29, 2018, the Planning Commission of the City of San Diego considered Rezone No. 2221513 and voted 7-0-0 to recommend City Council approval; and

WHEREAS, the matter was set for public hearing on March 5, 2019, testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Property is rezoned from the RS-1-2 zone to the CC-1-3 zone, as the zone is described and defined by San Diego Municipal Code section 131.0507. This action amends the Official Zoning Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance No. O-9030 (New Series), adopted June 4, 1964, of the

ordinances of the City of San Diego is repealed insofar as the same conflicts with Rezone

No. 2221513.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a

written copy having been made available to the City Council and the public prior to the day of its

passage.

Section 4. This Ordinance shall take effect and be in force on the thirtieth day from and

after its passage, and no building permits for development inconsistent with the provisions of this

Ordinance shall be issued unless application therefore was made prior to the date of adoption of

this Ordinance.


