AN ORDINANCE AMENDING CHAPTER 6, ARTICLE 3, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 63.0120, RELATING TO NIGHTTIME CURFEW FOR CERTAIN PUBLIC PARKS IN THE NORTH PARK AND CITY HEIGHTS AREAS.

WHEREAS, public parks in the City of San Diego (City) are intended for the enjoyment of the general public, including families with children and, in an effort to curtail violations of public laws during nighttime hours, the City previously established nighttime curfews at certain public parks; and

WHEREAS, the nighttime curfews in City parks serve as an effective means for the Police Department to minimize illegal use of the parks and prevent criminal and unsanitary activities, resulting in a safer environment for general public use; and

WHEREAS, the North Park Community Park, Montclair Neighborhood Park, Cedar Ridge Mini Park, North Park Mini Park, and City Heights Square Mini Park do not currently have a nighttime curfew; and

WHEREAS, the City's Park and Recreation Board voted to recommend adding the North Park Community Park, Montclair Neighborhood Park, Cedar Ridge Mini Park, North Park Mini Park, and City Heights Square Mini Park to the nighttime curfew; and

WHEREAS, City Staff has received reports of numerous incidents of lewd behavior in and around the North Park Community Park, Montclair Neighborhood Park, Cedar Ridge Mini Park, North Park Mini Park, and City Heights Square Mini Park including public intoxication, noise disturbances, vandalism, drug use, and drug sales; and

WHEREAS, the City Council desires to alleviate the negative impacts of persons frequenting the North Park Community Park, Montclair Neighborhood Park, Cedar Ridge Mini Park, North Park Mini Park, and City Heights Square Mini Park during the nighttime hours by providing a nighttime curfew; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 6, Article 3, Division 1 of the San Diego Municipal Code is amended by amending section 63.0120, to read as follows:

## § 63.0120 Nighttime Curfew for Certain Public Parks and the Spruce Street Pedestrian Bridge

- (a) It is unlawful for any person to be on the grounds of the following parks from midnight until 6:00 a.m.: Children's Park, Gaslamp Square Park, Pantoja Park, the Children's Museum Park, Fault Line Park, Cortez Hill Park, North Park Community Park, Montclair Neighborhood Park, Cedar Ridge Mini Park, and North Park Mini Park.
- (b) through (c) [No change in text.]
- (d) It is unlawful for any person to be on the grounds of the City Heights

  Square Mini Park from 9:00 p.m. until 5:00 a.m.
- Section 2. That a full reading of this Ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.
