DATE OF FINAL PASSAGE APR 25 2019

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE EXECUTION OF THE
2018 AMENDED AND RESTATED WATER CONSERVATION
GARDEN JOINT POWERS AGREEMENT.

WHEREAS, on February 2, 2004, via Resolution No. 298835, the City of
San Diego (City) received City Council approval to enter into the Joint Powers Agreement
Creating the Water Conservation Authority (JPA Agreement); and

WHEREAS, the participants to the JPA Agreement developed the Water Conservation
Garden (Garden) located on the property of Cuyamaca College to offer education on water
efficient landscaping and irrigation with special focus on landscape design, composting, native
plants, water-wise landscaping, maintenance, and irrigation at no cost to its visitors; and

WHEREAS, on April 5, 2016, the City Council authorized the approval of Ordinance
No. O-20631 to comply with current authorization requirements, seek approval for past and
future JPA Agreement membership dues and request authorization for the City's continued
participation in the JPA Agreement until the end of FY 2026; and

WHEREAS, in 2018, the JPA Agreement was amended and restated for the second time
to better reflect its current operations and composition with no changes that affect additional
time, funding or commitment of City resources and that all approvals for Ordinance No. O-
20631 are still accurate and in effect; and

WHEREAS, current City authorization requirements require that the 2018 Amended and
Restated Agreement be brought to City Council via Ordinance for approval and execution by the
Mayor or designee; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the 2018 Amended and Restated Agreement in connection with the Water Conservation Garden Joint Powers Agreement by way of ordinance, under the terms and conditions set forth in the 2018 Amended and Restated Agreement on file in the Office of the City Clerk as Document No. OO- 21068.

Section 2. That the Mayor, or his designee, is authorized to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, along with any amendments thereto and payment requests, in furtherance of the 2018 Amended and Restated Agreement.


Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


