AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE SECOND AMENDMENT TO AGREEMENT WITH PSOMAS FOR PROFESSIONAL SERVICES FOR DESIGN AND DESIGN SUPPORT DURING CONSTRUCTION; AND TAKING RELATED ACTIONS.

WHEREAS, the Montezuma/Mid-City Pipeline Phase 2 and 70th-Alvarado to Saranac-Sidewalk project will provide approximately 4,900 feet (0.93 miles) of 66-inch diameter cement mortar-lined and concrete (CMLC) steel pipeline as a parallel and redundant conveyance system to the Trojan Pipeline. It also includes installing new concrete sidewalk on the west side of 70th Street between Alvarado Road and Saranac Street; and

WHEREAS, the City entered into Contract No. H135950 by ordinance with Psomas in February 2014 (Resolution No. 308698, \$1,653,200), for professional engineering services for Mid-City Pipeline Phase 2 project. City Council approved the first amendment to the original contract in August 2017 (O-20846, \$277,917 for additional engineering design services to address a critical service connection at the Mohawk Pump Station.

The proposed second amendment (current action) will supplement the approved professional services and include additional design services during construction due to the design services related to the Caltrans encroachment permit and this action is requesting Council to approve the Second Amendment to the consultant agreement with Psomas for an amount not to exceed \$390,000; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Sub Item B

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an ordinance to execute a second amendment to the agreement with Psomas for engineering services in CIP S-11026, Montezuma/Mid-City Pipeline Phase 2 in an amount not to exceed \$390,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the Second Amendment to the Agreement, on file in the Office of the City Clerk as Document No. OO- 21073.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$390,000 from CIP S-11026, Montezuma/Mid-City Pipeline Phase 2, Fund 700010, Water Fund, for the purpose of executing one or more amendments to the agreement with Psomas, contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
