DATE OF FINAL PASSAGE JUN 06 2019

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE TENTH AMENDMENT TO
THE AGREEMENT WITH SAN DIEGO METROPOLITAN
TRANSIT SYSTEM FOR ADMINISTRATION OF TAXICAB
PROGRAM EXTENSION UNTIL JUNE 30, 2024.

WHEREAS, as permitted by California Public Utilities Code section 120266, the City has contracted with the San Diego Metropolitan Transit System (MTS) since 1988 for the administration of regulations for taxicabs and other for-hire transportation services; and

WHEREAS, in 2014, the Council of the City of San Diego (Council) adopted San Diego Ordinance O-20371 (June 23, 2014), authorizing the Ninth Amendment to the Agreement with the San Diego Metropolitan Transit System (MTS) for Administration of Taxicab and Other For-Hire Vehicle Regulations which expires June 30, 2019; and

WHEREAS, this action will extend the Agreement in which the San Diego Metropolitan Transit System (MTS) administers the City's regulatory program for taxicabs and other private for-hire transportation services until June 30, 2024; and

WHEREAS, MTS provides administrative services that are cost-effective and beneficial to the City, the for-hire transportation industry and consumers; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a Tenth Amendment to Agreement with the San Diego Metropolitan Transit


System (MTS) for Administration of Taxicab and Other For-Hire Vehicle Regulations, under the terms and conditions set forth in the document on file in the Office of the City Clerk as

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
