AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO EXEMPTING ONE PROGRAM COORDINATOR POSITION IN THE OFFICE OF THE CITY ATTORNEY FROM THE CLASSIFIED SERVICE OF THE CITY OF SAN DIEGO.

WHEREAS, on May 2, 2019 the San Diego Civil Service Commission (Civil Service Commission) reviewed a request from the Office of the City Attorney (Department) to exempt a limited part-time Program Coordinator position from the Classified Service of the City of San Diego (City); and

WHEREAS, the Program Coordinator position will be responsible for developing, reviewing, and implementing the Department's mobile safety applications; formulating security policies and procedures; advising staff on Department and Citywide policies and procedures; developing curriculum for training on human resources topics; and formulating and presenting operational and policy recommendations for all Department divisions; and

WHEREAS, San Diego City Charter (Charter) section 117 states the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, upon review of the duties and responsibilities of the Program Coordinator position, as described by the Department, the Civil Service Commission found it meets the intent of Charter section 117 to exempt the position from the Classified Service; and

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage. APPROVED: MARA W.
