AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AMENDMENTS TO THE DOWNTOWN COMMUNITY PLAN, GENERAL PLAN, AND THE CITY'S LOCAL COASTAL PROGRAM DESIGNATING LAND USE DISTRICTS, FLOOR AREA RATIOS AND HEIGHT LIMITS IN THE MARINA NEIGHBORHOOD OF THE DOWNTOWN COMMUNITY PLANNING AREA.

WHEREAS, the City of San Diego wishes to amend the Downtown Community Plan designating land use districts, floor area ratios and height limits within the Marina neighborhood of the Downtown Community Planning Area, specifically Figures 3-4 Land Use, 3-9 Base Minimum and Maximum FAR, 3-10 Maximum FAR Through Bonus Payment, 3-11 Total Bonus FAR Available (including through bonus payments), 3-12 Maximum FAR (with bonuses), and 5-2 Building Height and Sun Access; and

WHEREAS, the matter was set for public hearing on June 4, 2019, testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT ORDAINED, by the City Council of the City of San Diego, as follows:

Section 1. That notwithstanding San Diego Municipal Code sections 112.0509 and 122.0105, which provides for a Planning Commission hearing or recommendation prior to certain City Council actions, no Planning Commission hearing or recommendation is required related to the actions being authorized pursuant to this Ordinance.

Section 2. That the amendments to the Downtown Community Plan, on file in the office of the City Clerk as Document No. **62**-\_\_\_\_\_\_, are adopted.

Section 3. That a full reading of this Ordinance is dispensed with prior to its

passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That prior to becoming effective, this Ordinance shall be submitted to the San Diego County Regional Airport Authority (SDCRAA) for a consistency determination.

That if the SDCRAA finds this Ordinance consistent with the Airport Land Use

Compatibility Plans (ALUCP) for San Diego International Airport (SDIA), shall take effect and

be in force on the thirtieth day from and after the finding of consistency or on the thirtieth day

from and after its final passage, whichever is later, and except that the provisions of this

Ordinance inside the Coastal Overlay Zone, which are subject to California Coastal Commission

jurisdiction as a City of San Diego Local Coastal Program amendment shall not take effect until

the date the California Coastal Commission unconditionally certifies those provisions as a local

coastal program amendment.

That if the SDCRAA determines that this Ordinance is inconsistent or conditionally consistent, subject to proposed modifications, with the ALUCP for the SDIA, the Ordinance shall be submitted to the City Council for reconsideration.

That if the SDCRAA determines that this Ordinance is conditionally consistent with the ALUCP for the SDIA, but that consistency is subject to proposed modifications, the City Council may amend this Ordinance to accept the proposed modifications, and this Ordinance as amended shall take effect and be in force on the thirtieth day from and after its final passage, and except that the provisions of this Ordinance inside the Coastal Overlay Zone, which are subject to California Coastal Commission jurisdiction as a City of San Diego Local Coastal Program amendment shall not take effect until the date the California Coastal Commission unconditionally certifies those provisions as a local coastal program amendment.

That a proposed decision by the City Council to overrule a determination of

inconsistency or to reject the proposed modifications for a finding of conditional consistency

shall include the findings required pursuant to Public Utilities Code section 21670 and require a

two-thirds vote; the proposed decision and findings shall be forwarded to the SDCRAA,

California Department of Transportation, Division of Aeronautics, and the airport operators for

the Airports; and the City Council shall hold a second hearing not less than forty-five days from

the date the proposed decision and findings were provided, at which hearing any comments

submitted by the public agencies shall be considered and any final decision to overrule a

determination of inconsistency shall require a two-thirds vote.

If the City Council makes a final decision to overrule a determination of inconsistency,

this Ordinance shall take effect and be in force on the thirtieth day from and after its final

passage, and except that the provisions of this Ordinance inside the Coastal Overlay Zone, which

are subject to California Coastal Commission jurisdiction as a City of San Diego Local Coastal

Program amendment shall not take effect until the date the California Coastal Commission

unconditionally certifies those provisions as a local coastal program amendment.
