AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FOURTH AMENDMENT TO THE 2007 SAN DIEGO REGIONAL STORM WATER COPERMITTEES MEMORANDUM OF UNDERSTANDING.

WHEREAS, on January 24, 2007, the San Diego Regional Water Quality Control Board (RWQCB) issued Order No. R9-2007-0001 (2007 MS4 Permit) regulating discharges from the municipal separate storm sewer system (MS4); and

WHEREAS, the 2007 MS4 Permit regulates MS4 discharges from the City of San Diego, the County of San Diego, the San Diego Unified Port District, the San Diego Regional Airport Authority, and the cities of Carlsbad, Chula Vista, Coronado, Escondido, Imperial Beach, La Mesa, San Marcos, Del Mar, El Cajon, Encinitas, Lemon Grove, National City, Oceanside, Poway, Santee, Solana Beach, and Vista (Copermittees); and

WHEREAS, the 2007 MS4 Permit mandated that the Copermittees cooperate with respect to specified regional and watershed storm water pollution prevention activities; and

WHEREAS, the Copermittees entered into a Memorandum of Understanding to share the costs of shared watershed storm water compliance, which the City Council approved by Ordinance No. O-19699 on January 18, 2008 (2007 MOU); and

WHEREAS, the Copermittees entered into a First Amendment to the 2007 MOU, which the Mayor's designee approved on June 15, 2010; and

WHEREAS, on May 8, 2013, the RWQCB issued Order No. R9-2013-0001, as amended by Order Nos. R9-2015-0001 and R9-2015-0100, (2013 MS4 Permit) which superseded the 2007 MS4 Permit and which is still in effect, but requires the Copermittees to continue some programs under the 2007 MS4 Permit; and

WHEREAS, the Copermittees entered into a Second Amendment to the 2007 MOU to extend the term through August 31, 2015, such that the term of the 2007 MOU exceeded seven years, and which Second Amendment to the 2007 MOU the City Council approved by Ordinance No. O-20363 on May 15, 2014; and

WHEREAS, the Copermittees entered into a Third Amendment to the 2007 MOU to extend the term through August 31, 2019, which the City Council approved by Ordinance No. 20589 on January 28, 2016; and

WHEREAS, the Copermittees desire to enter into a Fourth Amendment to the 2007 MOU to extend the term through August 2024; and

WHEREAS, under San Diego City Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute a Fourth

Amendment to the 2007 San Diego Regional Stormwater Copermittees Memorandum of

Understanding to extend the term through August 2024, under the terms and conditions set forth
in the Fourth Amendment to the 2007 MOU, on file in the Office of the City Clerk as Document

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$2,555,027, from Fund 100000 – General Fund, Transportation and Storm Water

Department – Storm Water Division operating budget, for the purposes of executing the Fourth

Amendment to the 2007 MOU and funding the City's Fiscal Year 2020 share of the costs under the Fourth Amendment to the 2007 MOU, contingent on the Chief Financial Officer first

furnishing one or more certificates certifying that the funds necessary for the expenditure are, or

will be, on deposit with the City Treasurer.

Section 3. That the Chief Financial Officer is authorized to expend an additional

amount not to exceed \$7,910,658, from Fund 100000 - General Fund, Transportation and Storm

Water Department – Storm Water Division operating budget, for the purposes of executing the

Fourth Amendment to the 2007 MOU and funding the City's Fiscal Year 2021 to Fiscal Year

2024 share of the costs under the Fourth Amendment to the 2007 MOU, contingent on City

Council adoption of the corresponding fiscal year's appropriations Ordinance, and contingent

upon the Chief Financial Officer furnishing one or more certificates certifying that the funds

necessary for the expenditure are, or will be, on deposit with the City Treasurer.
