AN ORDINANCE AMENDING CHAPTER 6, ARTICLE 7, DIVISION 2 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 67.0222 RELATING TO ESTIMATION OF WATER BILLS.

WHEREAS, pursuant to current Public Utilities Department (Department) policy, water bills shall be calculated based on actual meter readings whenever feasible or on estimated water consumption when it is not feasible to read the meters pursuant to the Department's written procedures approved by the City Manager; and

WHEREAS, when a water bill is based on estimated water consumption, the City Council desires that the Department shall include a written notice to the consumer concurrently with the water bill, or electronic notice for consumers receiving paperless billing, indicating that the water bill was estimated; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 6, Article 7, Division 2, of the San Diego Municipal Code is amended by amending Sections 67.0222, to read as follows:

§67.0222 Regulation of Water System - Estimation of Water Bills

Water bills shall be calculated based on actual meter readings whenever feasible or on estimated water consumption when it is not feasible to read the meters pursuant to written procedures approved by the City Manager. When a water bill is based on estimated water consumption, the Department shall include a written notice to the consumer concurrently with the water bill, or electronic notice for consumers receiving paperless billing, indicating that the water bill was estimated.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.
