RESOLUTION NUMBER R- 312168

DATE OF FINAL PASSAGE JAN 11 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE A CONTRACT WITH PLATINUM ADVISORS, LLC FOR STATE LEGISLATIVE AND EXECUTIVE BRANCH CONSULTING SERVICES AND REPRESENTATION IN THE AMOUNT OF \$504,000.

WHEREAS, on October 10, 2018, the City of San Diego (City) issued Request for Proposal No. 10089498-19-K (RFP) for consultant advocacy services before State legislative and regulatory decision-makers; and

WHEREAS, Platinum Advisors, LLC (Consultant) submitted a response to the RFP and was selected as the best provider for State legislative and executive branch consulting services and representation based on the evaluation criteria; and

WHEREAS, this Contract will be for 3 years with the option, in the City's discretion, to extend for two (2) additional one (1) year periods, but will not exceed five (5) years without approval by ordinance pursuant to Charter section 99; and

WHEREAS, this Contract will be for the period of December 9, 2018 through December 9, 2021 and in the amount of \$168,000 per year for 3 years for a total of \$504,000 with the City reserving the option to renew the Contract for two (2) additional one (1) year periods under the terms and conditions of the Contract; and

WHEREAS, this Contract was considered by the Economic Development & Intergovernmental Relations Committee on December 6, 2018 and passed to the full Council by unanimous vote, with 1 Councilmember not present.


NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego,

1. The Mayor, or his designee, is authorized to execute a contract with Platinum Advisors, LLC for State Legislative and Executive Branch Consulting Services and Representation in the amount of \$504,000, under the terms and conditions set forth in the Contract, on file in the Office of the City Clerk as Document No. RR- 312168; and

2. The Chief Financial Officer is authorized to expend an amount not to exceed \$168,000 as follows: (1) \$75,600.00 from Fund No. 100000, General Fund, Cost Center Nos. 1316000001, 1411000013, 1516000001, 1914000022, 2113000011, 1714111101, and 2116000001, (2) \$16,800.00 from Fund No. 700039, General Fund, Cost Center No. 2115000011, (3) \$55,440.00 from Fund No. 700000, General Fund, Cost Center No. 2000000001, and (4) \$20,160.00 from Fund No. 700036, General Fund, Cost Center No. 1611000016, Office of the Mayor, for the purposes of executing the Agreement; contingent upon the adoption of the Fiscal Year 2020 Appropriation Ordinance and contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be on deposit with the City Treasurer.
