DATE OF FINAL PASSAGE FEB 11 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING THE REPORT OF THE INDEPENDENT BUDGET ANALYST REGARDING CITY COUNCIL BUDGET PRIORITIES FOR FISCAL YEAR 2020 AND DIRECTING THAT SAID REPORT BE DELIVERED TO THE MAYOR'S OFFICE TOGETHER WITH THE COUNCILMEMBERS' BUDGET PRIORITY MEMORANDA.

WHEREAS, pursuant to San Diego Charter section 69(b), each Councilmember is required to provide a memorandum to the Independent Budget Analyst (IBA) setting for the Councilmember's budget priorities for the next fiscal year and the IBA is required to provide an analysis of the City Council's budget priorities and prepare a budget priorities resolution for City Council consideration; and

WHEREAS, the IBA has prepared its Report dated January 23, 2019 entitled "FY 2020 City Council Budget Priorities" (FY 2020 Budget Priorities Report), incorporating the budget priorities of the individual Councilmembers; and


WHEREAS, on January 31, 2019, the Budget and Government Efficiency Committee (Committee) voted to forward the FY 2020 Budget Priorities Report to the City Council for approval, including certain recommendations made by the Committee and incorporated into the FY 2020 Budget Priorities Report; and

WHEREAS, pursuant to San Diego Charter sections 280(a)(1) and 295(b), this resolution is exclusively within the purview of the City Council and may be passed by the City Council on the date of introduction, which date shall be deemed the date of final passage, and is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that the FY 2020 Budget Priorities Report concerning City Council budget priorities for the Fiscal Year 2020 Budget, is hereby accepted, and the IBA is hereby directed to deliver that report, together with each Councilmembers' Fiscal Year 2020 Budget Priorities Memorandum, to the Mayor's Office for consideration during the preparation of the Fiscal Year 2020 proposed budget.

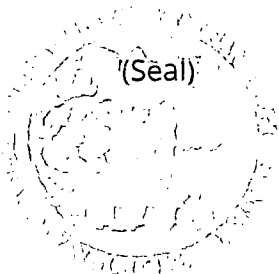
