A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ADVERTISEMENT, AWARD, AND EXECUTION OF THE CONTRACT FOR SLURRY SEAL GROUP 1924; EXECUTION OF SLURRY SEAL GROUP 1924 – OPTION RENEWAL CHANGE ORDER; AND TAKING RELATED ACTIONS.

WHEREAS, in Fiscal Year 2019, the Resurfacing Program plans to slurry seal 290 miles of streets. This action will authorize the advertisement, award, and execution of one contract to repair and seal approximately 60 miles of streets in 2019, and it will also authorize the execution of the option renewal change order for Slurry Seal Group 1924 to add authority for an additional 60 miles of streets as funding becomes available; and

WHEREAS, the contract for Slurry Seal Group 1924 involves furnishing all labor, materials, equipment, and construction, including crack sealing, pavement repair, slurry sealing, replacing traffic striping/markings, traffic control plans, and storm drain inlet protection on various public streets located throughout the City; and

WHEREAS, streets selected for Slurry Seal Group 1924 are located Citywide and are selected for slurry sealing based on the following established criteria:

- Overall Condition Index (OCI)
- Maintenance History
- Functional Classification
- Proximity to Emergency Facility/School/Tourist Attraction
- Mayor/Council Input

WHEREAS, the City of San Diego's street network includes approximately 2,668 centerline miles of asphalt streets. To replace and maintain the pavement surfaces on asphalt streets, the City's Street Resurfacing Program funds asphalt overlays and slurry seal treatments.

Slurry seal is an asphalt street surface treatment which consists of sand, emulsion, and water applied in a thin layer up to 3/8 of an inch thick. Slurry seal is used on streets which are generally in good condition to protect them from deterioration. Minor surface repairs are completed by pavement specialists prior to application of the slurry seal. Additionally, any failed areas of the pavement are removed and repaired prior to slurry seal application. The application of a slurry seal can protect and preserve the street pavement for approximately 3-7 years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. The Mayor, or his designee, is authorized to advertise, award and execute one construction contract with the lowest responsible and reliable bidder, in an amount not to exceed \$5,000,000 for the Slurry Seal Group 1924 project, contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
- 2. That the Chief Financial Officer is authorized to expend funds not to exceed \$5,000,000 from Fund 200118, Gas Tax Fund, for the purpose of funding Slurry Seal Group 1924 construction contract, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
- 3. The Mayor, or his designee, is authorized to execute the Slurry Seal Group 1924 Option Renewal Change Order in an amount not to exceed \$5,000,000, contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
- 4. That the Chief Financial Officer is authorized to expend funds not to exceed \$5,000,000 for Slurry Seal Group 1924 Option Renewal Change Order, contingent upon the

Chief Financial Officer furnishing a certificate certifying that the funds necessary for the construction contract expenditures are, or will be, on deposit with the City Treasury.
