A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN NICOLE PAPPAS AND THE CITY OF SAN DIEGO

WHEREAS, on September 13, 2017, NICOLE PAPPAS filed suit against the City of San Diego [City] alleging damages resulting from discrimination, retaliation and a hostile work environment. Nicole Pappas brought suit in the Superior Court for the County of San Diego. The suit is entitled *Nicole Pappas v. City of San Diego et al.*, San Diego Superior Court Case No. 37-2017-00033953-CU-OE-CTL [Litigation]; and

WHEREAS, in Closed Session on January 8, 2019, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, and 8; Nays, None; and Absent, 9, approved the settlement; and

WHEREAS, the City Council in Closed Session on January 8, 2019, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$275,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages and interest of any type against City of San Diego, its agents and employees, arising from the complaint filed by Nicole Pappas.

2. Authorizes the Chief Financial Officer to expend \$275,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Comptroller to issue a check in the amount of \$275,000.00, made payable to the Law Offices of Michael A. Conger Client Trust Account for the benefit of Nicole Pappas.
