A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND AVASANT, LLC FOR INFORMATION TECHNOLOGY CONSULTING SERVICES.

WHEREAS, On October 1, 2018, the Purchasing and Contracting Department issued Request for Proposal (RFP) No. 10089503-19-R, soliciting proposals from qualified providers for the provision of Information Technology Consulting Services; and

WHEREAS, after an extensive evaluation of qualified proposals, Avasant, LLC was selected to be awarded the contract; and


WHEREAS, the City requests the approval of a Resolution to authorize the Mayor or his designee to execute an Agreement with Avasant, LLC for Information Technology Consulting Services (Agreement), for a term of not more than three (3) years, with, at the sole discretion of the City, the option to extend the agreement for two (2) additional one (1) year periods, in an amount not to exceed \$650,000 over the five-year term of the Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the Agreement between the City of San Diego and Avasant, LLC for the provision of Information Technology Consulting Services, in an amount not to exceed \$650,000 over the five-year term of the Agreement, pursuant to the terms and conditions set forth in the Agreement, on file with the City Clerk as Document No. RR- 312225.

BE IT FURTHER RESOLVED, that that the Chief Financial Officer is authorized to expend an amount not to exceed \$650,000, from the Information Technology Fund (Fund

200308), over the five-year term of the Agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
