A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$3,665 TO TRANSFAMILY SUPPORT SERVICES FOR THE OUTREACH, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the TRANSFAMILY SUPPORT SERVICES has requested funding for outreach services; and

WHEREAS, the requested funding will be used to pay "tabling fees" in order to secure a presence on school campuses and other locations, as well as to cover the costs of supplying written materials, to Transgender and Gender Non-Binary children aged 17 and under at locations where they often congregate; and

WHEREAS, the TRANSFAMILY SUPPORT SERVICES's request for funding will benefit the public by being able to reach the community and public with Transfamily Support Services materials and contact information which in turn reduces the incidence of suicides, or attempted suicides, for young people and adults, and reduces substance abuse; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

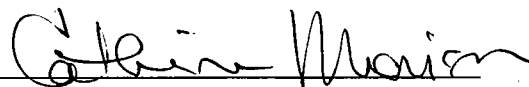
WHEREAS, Council Districts 3 and 5 recommend a total allocation of \$3,665 to the TRANSFAMILY SUPPORT SERVICES for the purposes set forth in this resolution, attributed as follows: Council District 3 – \$2,000; and Council District 5 –\$1,665; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the TRANSFAMILY SUPPORT SERVICES (Agreement) in an amount not to exceed \$3,665 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312230 .

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1103110003 GL512059 and \$1,665 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1105110005 GL512059, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
