A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING FREEWAY MAINTENANCE
AGREEMENTS WITH THE CALIFORNIA DEPARTMENT
OF TRANSPORTATION FOR THE MAINTENANCE
OF PORTIONS OF STATE HIGHWAYS I-805 AND SR-905.

WHEREAS, it is the policy of the State of California Department of
Transportation (Caltrans) to maintain State highways, including bridge structures, and for local
jurisdictions to assume the maintenance responsibility of the street surfaces of local roads which
cross over or under the Caltrans facility within the State right-of-way; and

WHEREAS, Freeway Maintenance Agreements (FMAs) memorialize these
responsibilities and allow the City to obtain encroachment permits from Caltrans for any needed
maintenance; and

WHEREAS, on December 8, 1966 and May 19, 2009, Caltrans and City executed
Freeway Agreements consenting to adjustments of the local street and road system required for
the development of portions of Interstate Highway Route 805 (I-805) within the jurisdictional
limits of the City as a freeway; and

WHEREAS, on March 27, 1969, May 23, 1972 and October 10, 2005, Caltrans and City
executed Freeway Agreements consenting to adjustments of the local street and road system
required for the development of portions of State Highway Route 905 (SR-905) within the
jurisdictional limits of the City as a freeway; and

WHEREAS, on May 16, 1973, the State and City executed FMA number 11-8074,
allocating maintenance responsibilities for a segment of I-805 and on October 22, 1976, Caltrans
and City executed FMA number 11-8109, allocating maintenance responsibilities for a segment
of SR-905; and

WHEREAS, due to the various construction activities resulting in modifications to these segments of I-805 and SR-905, Caltrans and City amend these Freeway Maintenance Agreements accordingly to reflect current alignments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with the California Department of Transportation for the maintenance of portions of State Highway I-805, 11-SD-805 Post Mile 26.5-28.9, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No.

2. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with the California Department of Transportation for the maintenance of portions of State Highway SR-905, 11-SD-905 Post Mile 3.6-11.6, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No.
