A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING THE 2019 LEGISLATIVE  
CALENDAR

WHEREAS, each year, the Council of the City of San Diego (City Council) adopts a schedule of meetings for the calendar year for the City Council and its Standing Committees, commonly referred to as the legislative calendar; and

WHEREAS, on December 17, 2018, the City Council adopted the 2019 Legislative Calendar, with the current calendar on file in the Office of the City Clerk as document No. RR-312153, and available on the City of San Diego website; and

WHEREAS, the San Diego Municipal Code allows the City Council to adopt a resolution that changes, when necessary, the time and place of a regular meeting, setting forth the circumstances necessitating the change; and

WHEREAS, the Council President now proposes to amend the 2019 Legislative Calendar; and

WHEREAS, amendments would reschedule a meeting of the City Council's Rules Committee, which will be considering proposed municipal ballot measures for the March 2020 election, to accommodate a change in the City of San Diego's elections calendar; and

WHEREAS, amendments will also allow the Legislative Calendar to reflect temporary name changes recently approved by the Council for two Council committees, based on a temporary Rule of Council approved on December 17, 2018, when the Infrastructure Committee was renamed the Active Transportation and Infrastructure Committee, and the Smart Growth and Land Use Committee was renamed the Land Use and Housing Committee; and

WHEREAS, the amendments proposed to the 2019 Legislative Calendar will:

1. Remove the Rules Committee meeting that was scheduled for Wednesday, July 10, 2019 at 2 p.m.
2. Add a Rules Committee meeting on Wednesday, July 31, 2019 at 1 p.m.
3. Rename the Infrastructure Committee as the Active Transportation and Infrastructure Committee throughout the calendar.
4. Rename the Smart Growth and Land Use Committee as the Land Use and Housing Committee throughout the calendar.
