A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO A RESOLUTION OF THE COUNCIL OF THE  
CITY OF SAN DIEGO APPROVING THE 2019 STATE AND  
FEDERAL LEGISLATIVE PLATFORM.

WHEREAS, each year the City Council approves a legislative platform that defines the City of San Diego's (City) policy priorities and provides a means to advance and protect the City's interests on those policy priorities, as well as on legislative and regulatory matters, on both the federal and state levels, including the regional and local levels; and

WHEREAS, the 2019 State and Federal Legislative Platform defines three overarching principles of good government that guide the City's actions on policy priorities: preserving local control, promoting fiscal stability and supporting funding opportunities; and

WHEREAS, the City's policy priorities as set forth in the 2019 State and Federal Legislative Platform are under the categories of (1) Homelessness, Housing Affordability, and Neighborhood Services, (2) Infrastructure, Water Reliability, and the Environment, (3) Jobs and the Economy, (4) Open Government and City Funding, (5) Public Safety, (6) Veterans Affairs, and (7) Workforce Development and Youth Opportunity; and


WHEREAS, both the guiding principles and the policy priorities allow for flexibility so that the City can proactively and quickly respond to legislative, regulatory, administrative and budget issues that may arise during the year; and

WHEREAS, the Mayor's Office has provided the City Council with a proposed 2019 State and Federal Legislative Platform outlining the guiding principles and policy priorities; and

WHEREAS, on February 7, 2019, the Economic Development and Intergovernmental Relations Committee unanimously approved the Mayor's recommended platform with additions that have been incorporated into the Platform; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the 2019 State and Federal Legislative Platform is hereby approved, as amended and revised by Council.

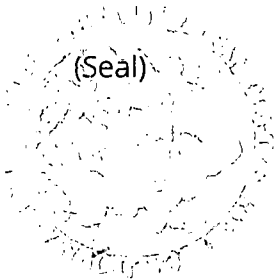
