A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$7,281 TO YOUNG AUDIENCES OF SAN DIEGO DBA ARTS FOR LEARNING SAN DIEGO FOR THE NEIGHBORHOOD LIBRARY INITIATIVE: NORTH UNIVERSITY, CENTRAL AND NORTH PARK AND LOGAN HEIGHTS LIBRARIES, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Young Audiences of San Diego dba Arts for Learning San Diego has requested funding for the Neighborhood Library Initiative: North University, Central and North Park and Logan Heights Libraries and

WHEREAS, the requested funding will be used to help continue to provide programming such as artist fees, supplies, books, printing of fliers, and books that are given to each family to 24 of the 35 libraries in the San Diego Public Library system; and

WHEREAS, the Young Audiences of San Diego dba Arts for Learning San Diego's request for funding for the Neighborhood Library Initiative: North University, Central and North Park and Logan Heights Libraries will benefit public by providing residents with easy access to

the arts, additionally, these free community programs promote family connectivity and a safe haven for teens, which is especially important for families in District 7; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 3 and 8 recommend a total allocation of \$7,281 to the Young Audiences of San Diego dba Arts for Learning San Diego for the purposes set forth in this resolution, attributed as follows: Council District 1 - \$2,500; Council District 3 - \$2,000; and Council District 8 - \$2,781; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Young Audiences of San Diego dba Arts for Learning San Diego (Agreement) in an amount not to exceed \$7,281 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312252.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1101110001 GL512059; \$2,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1103110003; and \$2,781 from Council District 8: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1108110008, for a total of \$7,281, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
