WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Treobytes, LLC has requested funding for the STEAM Vocational

Enrichment Program (Program) which serves under represented youth to make technology
accessible and to learn the basics of programming, vocational pathways and STEAM projects in
a team environment; and

WHEREAS, the requested funding will be used to continue the Program throughout the 2019 Summer and the 2019/2020 school year; and

WHEREAS, Treobytes, LLC's request for funding for the STEAM Vocational Enrichment Program will benefit public by bridging the STEAM exposure gap; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1 and 5 recommend a total allocation of \$3,000 to the

Treobytes, LLC for the purposes set forth in this resolution, attributed as follows: Council

District 1 – \$2,000; and Council District 5 – \$1,000; NOW, THEREFORE,

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2019 City Council Allocations Agreement between the City of San Diego and the Treobytes,

LLC (Agreement) in an amount not to exceed \$3,000 for the project described in this resolution,

under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as

Document No. RR- 312256

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$2,000 from Council District 1: Community Projects, Programs and

Services budget Fund No. 100000, Cost Center No. 1101110001 GL512059; and \$1,000 from

Council District 5: Community Projects, Programs and Services budget Fund No. 100000, Cost

Center No. 1105110005 GL512059, for a total of \$3,000, all to provide funds for the above-

referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more

certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the

City Treasurer.
