WHEREAS, the Mira Mesa Chamber of Commerce's request for funding for Marketing and Membership Outreach will benefit public by giving businesses in the community a stronger Chamber of Commerce and, by doing so, the Chamber can facilitate access to programs that will allow the community to grow and prosper; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and
