WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Big Brothers Big Sisters of San Diego County has requested funding for its Community Mentoring: Recruitment Campaign; and

WHEREAS, the requested funding will be used to invest in the Recruitment team, by providing them with new, branded materials such as pop up tents, banners and table cloths to attract attention and promote a polished, professional organization and volunteer opportunity; and

WHEREAS, Big Brothers Big Sisters of San Diego County's request for funding for the Community Mentoring: Recruitment Campaign will benefit the public by assisting the organization to recruit at-risk youth to pair "littles" with "bigs," thereby increasing the "little's" confidence to achieve their goals, better educational opportunities, engage in less risky behaviors, and build stronger family relationships; and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2019 City Council Allocations Agreement between the City of San Diego and the Big

Brothers Big Sisters of San Diego County (Agreement) in an amount not to exceed \$1,500 for

the project described in this resolution, under terms and conditions set forth in the Agreement on

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$1,500 from the Community Projects, Programs, and Services budget

above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit

with the City Treasurer.
