A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$7,000 TO MEALS-ON-WHEELS GREATER SAN DIEGO, INC. FOR THE SENIOR CARE IN THE HOME, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Meals-on-Wheels Greater San Diego, Inc. has requested funding for its Senior Care in the Home program; and

WHEREAS, the requested funding will be used for printing its service brochure, volunteer recruitment brochure and pertinent flyers and having them translated into Spanish for distribution throughout the City; and

WHEREAS, Meals-on-Wheels' request for funding for the Senior Care in the Home program will benefit the public by addressing food insecurity issues, declining health, and social isolation experienced by seniors in communities with a high concentration of older adults; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 2, 3 and 5 recommend a total allocation of \$7,000 to the Meals-on-Wheels for the purposes set forth in this resolution, attributed as follows: Council District 2 - \$4,000; Council District 3 -\$1,500 and Council District 5 -\$1,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Meals-on-Wheels (Agreement) in an amount not to exceed \$7,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312279.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$4,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002 GL512059; \$1,500 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1103110003 GL512059; and \$1,500 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1105110005 GL512059, for a total of \$7,000, all to provide funds for the above-referenced Agreement, contingent upon the
