A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING EXECUTION OF A
COOPERATIVE PROCUREMENT CONTRACT WITH HERC
RENTALS, INC., FOR AS-NEEDED RENTAL OF VARIOUS
LIGHT TO HEAVY EQUIPMENT.

WHEREAS, On May 22, 2018, the City of Charlotte, North Carolina issued Request for Proposal (RFP) No. 269-2018-047 for equipment rental; and

WHEREAS, on November 1, 2018, based on the results of the competitive bid process, the City of Charlotte awarded to Herc Rentals, Inc. (HERC) a contract for five years with two additional two-year options (Contract No. 2019000318); and

WHEREAS, On February 20, 2019, the City's Purchasing Agent certified in writing that the Contract meets the requirements set forth in San Diego Municipal Code section 22.3208 based on the following reasons: (1) The Contract is in the best interest of the City because it will ensure timely completion of construction projects by allowing City forces access to an extensive list of equipment options that are readily available; (2) The Contract was awarded using a process that complies with the Policies and Regulations as stipulated in the San Diego Municipal Code; and (3) The Contract is to the City's economic advantage because HERC has agreed to provide equipment rentals at Platinum-Level pricing, which is an average of a 40% discount from published retail pricing; and

WHEREAS, the City requests the approval of a Resolution to authorize the Mayor or his designee to execute a Cooperative Procurement Contract with Herc Rentals, Inc. for various light to heavy equipment (Agreement), for a term through November 1, 2023, with, at the sole discretion of the City, and contingent on approval of an ordinance of the City Council, the option

to extend the agreement for two (2) additional two-year terms, in an amount not to exceed \$14,325,000 over the five-year term of the Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, the Agreement between the City of San Diego and Herc Rentals, Inc. for rental equipment, in an amount not to exceed \$14,325,000 over the five-year term of the Agreement, pursuant to the terms and conditions set forth in the Agreement, on file with the City Clerk as Document No. RR- 312299.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$14,325,000 over the five-year term of the Agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


