A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND RATIFYING AN AGREEMENT TO AMEND THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO AND THE SAN DIEGO MUNICIPAL EMPLOYEES' ASSOCIATION RELATED TO SHIFT ROTATION PAY FOR DISPATCHERS IN THE POLICE AND FIRE-RESCUE DEPARTMENTS.

WHEREAS, by San Diego Resolution R-310148 (Dec. 16, 2015), the San Diego City Council (Council) approved and ratified a Memorandum of Understanding (MOU) between the City of San Diego (City) and the San Diego Municipal Employees' Association (MEA) that establishes terms and conditions of employment for MEA-represented employees for Fiscal Years 2017 through 2020; and

WHEREAS, the City and MEA have reached a tentative agreement to amend Article 21 of the MOU by adding new section I, related to shift rotation pay for dispatchers in the City's Police and Fire-Rescue Departments; and

WHEREAS, the proposed amendments are set forth in the agreement, which is now presented to the Council for final determination, in accordance with the Meyers-Milias-Brown Act and Council Policy 300-06; and

WHEREAS, this agreement to amend the MOU requires approval of a two-thirds majority vote of the Council, pursuant to San Diego Charter section 11.2; NOW THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that the agreement to amend the MOU between the City and the MEA, presented to the Council and on file in the Office of the City Clerk as Document No. RR-312302 is approved and ratified, and takes effect on July 1, 2019.

BE IT FURTHER RESOLVED that the Council directs the City's management team to incorporate the provisions set forth in the approved agreement in any successor MOU, unless the provisions are modified by future negotiations and presented to the Council for approval, in accordance with the Meyers-Milias-Brown Act and Council Policy 300-06.


