A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DEDICATING PUBLIC RIGHTS-OF-WAY FOR A PORTION OF 43RD STREET, A PORTION OF SAN PASQUAL STREET, A PORTION OF NATIONAL AVENUE, AND A PORTION OF THE INTERSECTION OF 43RD STREET, SAN PASQUAL STREET, NATIONAL AVENUE, AND LOGAN AVENUE.

WHEREAS, the City of San Diego (City) previously authorized the realignment of the 43rd Street and National/Logan Avenue Intersection in order to improve traffic flow and pedestrian access along this corridor; and

WHEREAS, the realignment of National Avenue, 43rd Street, Logan Avenue, and San Pasqual Street has been constructed to the roadway's ultimate width at the intersection; and

WHEREAS, the purpose of the public rights-of-way dedication is to accurately reflect the completed realignment of the roadway; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the dedication of a portion of 43rd Street in that area described as a portion of Lot 21 of Block 59, according to Map No. 27 filed in the Office of the County Recorder of San Diego County on October 1, 1880.


BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the dedication of a portion of San Pasqual Street in that area described as a portion of Lot 21 of Block 59, according to Map No. 27 filed in the Office of the County Recorder of San Diego County on October 1, 1880.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the dedication of a portion of National Avenue in that area

described as a portion of Lot 21 of Block 59, according to Map No. 27 filed in the Office of the County Recorder of San Diego County on October 1, 1880.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the dedication of a portion of the intersection of 43rd Street, San Pasqual Street, National Avenue, and Logan Avenue in that area described as a portion of Lot 21 of Block 59, according to Map No. 27 filed in the Office of the County Recorder of San Diego County on October 1, 1880.


