A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN TERRA GODFREY AND THE CITY OF SAN DIEGO.

WHEREAS, on August 17, 2017, Plaintiff Terra Godfrey filed suit against the City of San Diego alleging property damage arising from the overflow of City's storm water/flood control channel that occurred between July 2012 and August 2016. The suit is entitled *Terra Godfrey v. City of San Diego*, San Diego Superior Court, Case No. 37-2017-00030554-CU-EI-CTL; and

WHEREAS, in closed session on March 12, 2019, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none; Absent, none, approved the settlement of Plaintiff's claims for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in a settlement agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of two hundred forty-five thousand dollars (\$245,000.00) from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against City of San Diego, its agents and employees, arising from the property damage claim of *Terra Godfrey v. City of San Diego*, San Diego Superior Court, Case No. 37-2017-00030554-CU-EI-CTL.

- 2. Authorizes the Chief Financial Officer to expend \$245,000.00 from the Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorizes the Comptroller to issue a check in the amount of \$245,000.00 made payable to Lieb & Lieb Client Trust Account.
