A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$9,500 TO MANA DE SAN DIEGO FOR THE EMPOWERING LATINAS THROUGH EDUCATION, TRAINING AND MENTORSHIP, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the MANA de San Diego has requested funding for the Empowering Latinas through Education, Training and Mentorship; and

WHEREAS, the requested funding will be used to support Latina youth and professionals throughout San Diego to succeed academically and professionally by providing them with printing/supplies, marketing/promotional efforts, online tools/platform, program staff and speaker/venue fees; and

WHEREAS, the MANA de San Diego's request for funding for the Empowering Latinas through Education, Training and Mentorship will benefit the public by supporting programs that educate and empower Latinas to reach their full potential so they can compete for high-skilled positions and provide for their families; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 1, 2, 4 and 5 recommend a total allocation of \$9,500 to the MANA de San Diego for the purposes set forth in this resolution, attributed as follows: Council District 1 - \$1,000; Council District 2 -\$5,000; Council District 4 -\$2,500 and Council District 5 -\$1,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the MANA de San Diego (Agreement) in an amount not to exceed \$9,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312320.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Council District 1: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1101110001 GL512059; \$5,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002 GL512059; \$2,500 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1104110004 and \$1,000 from

Council District 5: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1105110005 GL512059, for a total of \$9,500, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
