A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$2,500 TO POINT LOMA ASSOCIATION FOR THE VOLTAIRE STREET BRIDGE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Point Loma Association has requested funding for the Voltaire Street Bridge project, which will add decorative improvements to the bridge overhaul; and

WHEREAS, the requested funding will be used for design, engineering and purchase of materials for the decorative improvements; and

WHEREAS, the Point Loma Association's request for funding for the Voltaire Street Bridge to benefit the public by increasing the walkability and bike ability of Voltaire Street which will benefit local businesses and give residents more community shopping and service choices, as well as increased community pride; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 2 recommends an allocation of \$2,500 to the Point Loma

Association for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services
