A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$1,500 TO MAINLY MOZART, INC. FOR THE 31ST ANNUAL MAINLY MOZART FESTIVAL, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Mainly Mozart, Inc. has requested funding for the 31st Annual Mainly Mozart Festival; and

WHEREAS, the requested funding will be used for production expenses such as the venue rental, piano rental, artist fees, technical crew and promotion, for events that are open to the public and free of charge; and

WHEREAS, Mainly Mozart, Inc.'s request for funding for the 31st Annual Mainly
Mozart Festival will benefit the public by enabling District 3 residents and outreach groups who
have free access to the Mainly Mozart Festival Orchestra and the Mainly Mozart Youth
Orchestra to witness firsthand the benefits of early music education and to enjoy classical music
performance; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 3 recommends an allocation of \$1,500 to Mainly Mozart, Inc. for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Mainly Mozart, Inc. (Agreement) in an amount not to exceed \$1,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312329.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,500 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1103110003 GL512059, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
