A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$23,000 TO CITY HEIGHTS COMMUNITY DEVELOPMENT CORPORATION FOR THE MID-CITY HOMELESS OUTREACH PROJECT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City Heights Community Development Corporation has requested funding for the Mid-City Homeless Outreach Project; and

WHEREAS, the requested funding will be used to support the launch of a one-year pilot program to hire a full-time Homeless Outreach Specialist; and

WHEREAS, the City Heights Community Development Corporation's request for funding for the Mid-City Homeless Outreach Project will benefit the public by connecting homeless persons to housing, services, and other supports. In addition, the funding will benefit the people who reside, work, and shop in the targeted neighborhoods of North Park and City Heights by reducing the negative impacts to communities of homelessness; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 3 and 9 recommend a total allocation of \$23,000 to the City Heights Community Development Corporation for the purposes set forth in this resolution, attributed as follows: Council District 3 – \$20,000; and Council District 9 –\$3,000; NOW, THEREFORE.

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the City Heights Community Development Corporation (Agreement) in an amount not to exceed \$23,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312332.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$20,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1103110003 GL512059; and \$3,000 from Council District 9: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1109110009 GL512059, for a total of \$23,000, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more
