A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$6,500 TO SAN DIEGO CONTINUING EDUCATION FOUNDATION FOR THE EDUCATIONAL CULTURAL COMPLEX (ECC) HISTORICAL PRESERVATION, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego Continuing Education Foundation has requested funding for the Educational Cultural Complex (ECC) Historical Preservation; and

WHEREAS, the requested funding will be used to support several projects that will help the program achieve its goal of preserving the history of ECC such as publishing the history of ECC book, trophy cases, art installations, plaques/virtual self-guided tour apps and virtual self-guided tour welcome kiosk; and

WHEREAS, the San Diego Continuing Education Foundation's request for funding for the Educational Cultural Complex (ECC) Historical Preservation will benefit the public by educating the community about the historic contributions that ECC has made to racial equality and social justice in California and nationwide; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 4 and 9 recommend a total allocation of \$6,500 to the San Diego Continuing Education Foundation or the purposes set forth in this resolution, attributed as follows: Council District 4 – \$5,000; and Council District 9 –\$1,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the San Diego Continuing Education Foundation (Agreement) in an amount not to exceed \$6,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312334.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1104110004 GL512059; and \$1,500 from Council District 9: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1109110009 GL512059, for a total of \$6,500, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more

certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
