A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$10,000 TO SAN DIEGO NORTH CHAMBER OF COMMERCE DBA NORTH SAN DIEGO BUSINESS FOR THE HOMELESS VETERANS EMPLOYMENT INITIATIVE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego North Chamber of Commerce dba North San Diego Business has requested funding for the Homeless Veterans Employment Initiative including a one-day complimentary professional development training; and

WHEREAS, the requested funding will be used to provide class materials free of charge, such as printing of class handouts, printing of materials which are normally digital, notebooks, pens, signage, compensation for the instructor and other speakers' time and rental of meeting space, insurance, etc.; and

WHEREAS, the San Diego North Chamber of Commerce dba North San Diego
Business's request for funding for the Homeless Veterans Employment Initiative will benefit the
public by providing homeless veterans with instruction and mentorship on how to find jobs in the
region as well as provide connections to business leaders; and

WHEREAS, it is the determination of the City Council that the above-described program

fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$10,000 to the San Diego

North Chamber of Commerce dba North San Diego Business for the purposes set forth in this

resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2019 City Council Allocations Agreement between the City of San Diego and the San Diego

North Chamber of Commerce dba North San Diego Business (Agreement) in an amount not to

exceed \$10,000 for the project described in this resolution, under terms and conditions set forth

in the Agreement on file in the Office of the City Clerk as Document No. RR- 312335.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$10,000 from the Community Projects, Programs, and Services budget

Fund No. 100000, Cost Center 1105110005 GL512059, to provide funds for the

above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit

with the City Treasurer.
