WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Concerned Parents Alliance has requested funding for its College Bound Program, which serves underrepresented, under-served and under-resourced scholars and their parents or guardians to navigate the educational system; and

WHEREAS, the requested funding will be used to pay stipends/fees for speakers with an expertise in the college application process, scholarships, grants and other financial opportunities. Some funds will also be allocated to printing materials so that they have information to refer to; and

WHEREAS, the Concerned Parents Alliance's request for funding for the College Bound Program will benefit the public by increasing the rate of college bound youth in the underrepresented and under-served members in the College Bound Program who live within the Rancho Penasquitos and Rancho Bernardo areas; and

WHEREAS, it is the determination of the City Council that the above-described program

fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$1,500 to the Concerned

Parents Alliance for the purposes set forth in this resolution; NOW, THEREFORE,

described in this resolution is made for a public purpose.
