A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$14,752 TO SAN YSIDRO IMPROVEMENT CORPORATION FOR THE INDEPENDENCE FESTIVAL @ THE BORDER / GRAFFITI ABATEMENT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Ysidro Improvement Corporation has requested funding for the Independence Festival @ the Border / Graffiti Abatement; and

WHEREAS, the requested funding will be used for event production costs and to purchase graffiti abatement equipment such as a power washer, painter and chemicals; and

WHEREAS, the San Ysidro Improvement Corporation's request for funding for the Independence Festival @ the Border / Graffiti Abatement will benefit the public by giving the community the opportunity to showcase their area and the sense of patriotic pride in their own community; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$14,752 to the San Ysidro

Improvement Corporation for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06,

section 3(g), which provides: "An organization may not apply to receive funding for an event or

program which has already occurred, nor any capital improvement, goods, supplies, materials, or

equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

Improvement Corporation (Agreement) in an amount not to exceed \$14,752 for the project

described in this resolution, under terms and conditions set forth in the Agreement on file in the

an amount not to exceed \$14,752 from the Community Projects, Programs, and Services budget
