A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$4,000 TO CLAIREMONT HILLS KIWANIS FOUNDATION FOR THE COMMUNITY MOVIE NIGHTS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Clairemont Hills Kiwanis Foundation has requested funding for the Community Movie Nights at various elementary schools in the Clairemont community; and

WHEREAS, the requested funding will be used to cover expenses of both presentation and movie licensing; and

WHEREAS, the Clairemont Hills Kiwanis Foundation's request for funding for the Community Movie Nights will benefit the public by bringing both businesses and community together with schools to foster community interaction and connection; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 2 and 6 recommend a total allocation of \$4,000 to the

Clairemont Hills Kiwanis Foundation for the purposes set forth in this resolution, attributed as

follows: Council District 2 – \$1,500; and Council District 6 – \$2,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2019 City Council Allocations Agreement between the City of San Diego and the Clairemont

Hills Kiwanis Foundation (Agreement) in an amount not to exceed \$4,000 for the project

described in this resolution, under terms and conditions set forth in the Agreement on file in the

Office of the City Clerk as Document No. RR- 312356

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$1,500 from Council District 2: Community Projects, Programs and

Services budget Fund No. 100000, Cost Center No. 1102110002 GL512059; and \$2,500 from

Council District 6: Community Projects, Programs and Services budget Fund No. 100000, Cost

Center No. 1106110006 GL512059, for a total of \$4,000, all to provide funds for the above-

referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more

certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the

City Treasurer.
