A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$1,500 TO BAYSIDE COMMUNITY CENTER FOR THE ONE LINDA VISTA: COMMUNITY ROOM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Bayside Community Center has requested funding for the One Linda Vista: Community Room; and

WHEREAS, the requested funding will be used to purchase folding tables and chairs, a projector and projector screen, sound system, computers (HP Elitebooks) plus necessary locking and safety devices. In addition, room dividers, community room space and small appliances will be purchased; and

WHEREAS, the Bayside Community Center's request for funding for the One Linda Vista: Community Room will benefit the public by supporting the Center in providing central space in Linda Vista for community members to convene, gather, present, plan, and dialogue; and

fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 2 recommends an allocation of \$1,500 to the Bayside

Community Center for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2019 City Council Allocations Agreement between the City of San Diego and the Bayside

Community Center (Agreement) in an amount not to exceed \$1,500 for the project described in

this resolution, under terms and conditions set forth in the Agreement on file in the Office of the

City Clerk as Document No. RR- 312357

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$1,500 from the Community Projects, Programs, and Services budget

Fund No. 100000, Cost Center 1102110002 GL512059, to provide funds for the

above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit

with the City Treasurer.
