A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$2,000 TO THE SAN DIEGO RIVER PARK FOUNDATION FOR THE BETTER FUTURE FOR THE SAN DIEGO RIVER, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, The San Diego River Park Foundation has requested funding for the Better Future for the San Diego Rive program; and

WHEREAS, the requested funding will be used to purchase supplies and materials and other program expenses to implement program activities, including clean-ups, water quality monitoring, surveys and youth education events; and

WHEREAS, The San Diego River Park Foundation's request for funding for the Better Future for the San Diego River program will benefit the public by increasing the quality of life for community members by connecting to the River itself, by experiencing it through outdoor recreation and nature discovery, by providing education about the threats facing environmental stewardship, and by keeping the River healthy and safe; and

WHEREAS, by providing ways in which the public can connect to the River, program volunteers can help ensure that the River Park and Trails remain a resource for the community to explore nature, recreate and spend time outdoors with their families; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 2 recommends an allocation of \$2,000 to the San Diego River Park Foundation for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the San Diego River Park Foundation (Agreement) in an amount not to exceed \$2,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312359.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1102110002 GL512059, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
