A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$2,500 TO PAVING GREAT FUTURES FOR THE PAVING GREAT FUTURES COMMUNITY WRAP AROUND, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Paving Great Futures has requested funding for the Paving Great Futures Community Wrap Around, which involves several program segments: (1) Culinary Hospitality Administrative Management Program, (2) Financial Literacy and Investment Program, (3) Leadership and Civic Engagement Development Program, (4) Engineering Music Program Inspiring Rising Entrepreneurs, and (5) Generously Investing Valuable Energy; and

WHEREAS, the requested funding will be used to purchase supplies and materials for participation in the wrap around programs, assist with the cost of speaking engagements, and support participants launch businesses that result from the wrap around; and

WHEREAS, the Paving Great Future's request for funding for the Paving Great Futures

Community Wrap Around will benefit the public by helping mobilize forces of people

disengaged and underrepresented and inform them on policy, legislation, and rejecting systems that work against helping them achieve; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an allocation of \$2,500 to the Paving Great Futures for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Paving Great Futures (Agreement) in an amount not to exceed \$2,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR
312362

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1104110004 GL512059, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
