A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO DEPOSITING EMPOWERMENT THROUGH OUTREACH & URBAN REDEVELOPMENT FOR THE F.A.N.C.Y. IN STEAM PROJECT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Depositing Empowerment Through Outreach & Urban Redevelopment has requested funding for the F.A.N.C.Y. in STEAM project; and

WHEREAS, the requested funding will be used to fund program costs needed for the FANCY STEAM Fair, admission to activities, youth development team building activities, program uniforms, art reach workshops, marketing, and program supplies; and

WHEREAS, the Depositing Empowerment Through Outreach & Urban Redevelopment's request for funding for the F.A.N.C.Y. in STEAM project will benefit the public by providing a centralized location for teen girls to receive STEAM education, with DETOUR maximizing participation of various teens, organizations, vendors, sponsors, and parents in the project through community commitees; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to the Depositing Empowerment Through Outreach & Urban Redevelopment for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Depositing Empowerment Through Outreach & Urban Redevelopment (Agreement) in an amount not to exceed \$5,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- $\frac{312365}{12365}$.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1104110004 GL512059, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or
