DATE OF FINAL PASSAGE APR 17 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$3,000 TO ENVIRONMENTAL HEALTH COALITION FOR THE BARRIO LOGAN TRUCK ROUTES AND AIR MONITORING PROJECT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Environmental Health Coalition has requested funding for the Barrio Logan Truck Routes and Air Monitoring Project; and

WHEREAS, the requested funding will be used to purchase equipment to assist in air quality and truck monitoring, such as outdoor cameras and a set of walkie talkes; and

WHEREAS, the Environmental Health Coalition's request for funding for the Barrio Logan Truck Routes and Air Monitoring Project will benefit the public by enabling the organization to study the number of heavy-duty vehicles that are present in residential areas at multiple times during the day and to communicate with community leaders more efficiently during air monitoring; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and


WHEREAS, Council District 8 recommends an allocation of \$3,000 to the Environmental Health Coalition for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Environmental Health Coalition (Agreement) in an amount not to exceed \$3,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312375.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1108110008 GL512059, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


