A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN STEVE PAGACH AND THE CITY OF SAN DIEGO.

WHEREAS, on February 1, 2018, STEVE PAGACH filed suit against Oswaldo Orozco and the City of San Diego alleging personal injuries arising from a motor vehicle vs. pedestrian accident at or near Brighton Avenue and Spray Street, in the City of San Diego, on August 26, 2017. Plaintiff brought suit in the San Diego Superior Court. The suit is entitled *Steve Pagach* v. City of San Diego, et al., San Diego Superior Court Case No. 37-2018-00005688-CU-PO-CTL; and

WHEREAS, in Closed Session on March 19, 2019, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and All Present, approved the Settlement; and

WHEREAS, the City Council in Closed Session on March 19, 2019, authorized settlement of the Litigation for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. A resolution authorizing the Mayor or his designee to pay the sum of \$280,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury Complaint filed by Steve Pagach, entitled *Steve Pagach v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2018-00005688-CU-PO-CTL.

- 2. Authorize the Chief Financial Officer to expend \$280,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorize the Comptroller to issue a check in the amount of \$280,000.00, made payable to Harris Personal Injury Lawyers, Inc.
