A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$7,410 TO KITCHENS FOR GOOD FOR THE NOURISHING KIDS MEAL PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Kitchens for Good has requested funding for the Nourishing Kids Meal Program; and

WHEREAS, the requested funding will be used to sustain and expand the program, specifically, funds will be used to cover the cost of a full-time driver starting July 1, 2018, which will greatly enhance the ability of Kitchens for Good to efficiently distribute meals across meal sites as demand increases; and

WHEREAS, the Kitchens for Good's request for funding for the Nourishing Kids Meal
Program will benefit the public by developing young people's healthy lifestyles, thereby
decreasing the likelihood of chronic illness and obesity while increasing the focus on learning in
school; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 4 and 9 recommend a total allocation of \$7,410 to the Kitchens for Good for the purposes set forth in this resolution, attributed as follows: Council District 4 – \$5,000; and Council District 9 –\$2,410; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Kitchens for Good (Agreement) in an amount not to exceed \$7,410 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312416.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1104110004 GL512059; and \$2,410 from

Council District 9: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1109110009 GL512059, for a total of \$7,410, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
