A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$1,000 TO SAN DIEGO SECOND CHANCE PROGRAM FOR THE YOUTH GARDEN, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego Second Chance Program has requested funding for its Youth Garden; and

WHEREAS, the requested funding will be used to help cover expenses related to the Garden; and

WHEREAS, the San Diego Second Chance Program's request for funding for the Youth Garden will benefit the public by supporting a program that provides at-risk youth with a sense of responsibility for the growth, harvest and sale of fresh produce and the basics of running their own business through the sale of fresh fruits and vegetables; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$1,000 to the San Diego Second Chance Program for the purposes set forth in this resolution; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, 3b, which provides: "A request for funding and subsequent allocation may not be less than \$1500;"

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the San Diego Second Chance Program (Agreement) in an amount not to exceed \$1,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312419 .

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1105110005 GL512059, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
