A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$9,000 TO RANCHO DE LOS PENASQUITOS TOWN COUNCIL FOR THE FIESTA DE LOS PENASQUITOS, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCE TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by San Diego Resolution R-307625; and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the Rancho de los Penasquitos Town Council has requested funding for the Fiesta de los Penasquitos; and

WHEREAS, the requested funding will be used for expenses associated with marketing the Fiesta, the 5K Fun Run and the parade, as well as for equipment rental and supplies; and

WHEREAS, the Rancho de los Penasquitos Town Council's request for funding for the Fiesta de los Penasquitos will benefit the public by supporting the Fiesta which celebrates the cultural and ethnic diversity in the community, as well as celebrating the arts, cultures and creativity of the Rancho Penasquitos neighborhoods; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-23; and

WHEREAS, Council Districts 5 and 6 recommend a total allocation of \$9,000 to the Rancho de los Penasquitos Town Council for the purposes set forth in this resolution, attributed as follows: Council District 5 – \$6,500; and Council District 6 –\$2,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement between the City of San Diego and the Rancho de los Penasquitos Town Council (Agreement) in an amount not to exceed \$9,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312420.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$6,500 from Council District 5: Fund No. 200205, Cost Center 1414111216 GL512059 and \$2,500 from Council District 6: Fund No. 200205, Cost Center 1414111217 GL512059, for a total of \$9,000, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
