A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO ALLIED GARDENS COMMUNITY EVENTS FOR THE ALLIED GARDENS/GRANTVILLE FIRST FRIDAYS COMMUNITY CONCERTS, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCE TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by San Diego Resolution R-307625; and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the Allied Gardens Community Events has requested funding for the Allied Gardens/Grantville First Fridays Community Concerts; and

WHEREAS, the requested funding will be used for the stage and sound system, and the permits required to host the event at the Allied Gardens Recreation Center; and

WHEREAS, the Allied Gardens Community Events' request for funding for the Allied Gardens/Grantville First Fridays Community Concerts will benefit the public by bringing large numbers of people to the community to enjoy music and to build a stronger community bond; and

WHEREAS, it is the determination of the City Council that the above-described program

fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 7 recommends an allocation of \$5,000 to the Allied

Gardens Community Events for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23(3)(g),

which provides: "An organization may not apply to receive funding for an event or program which

has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which

have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, an Agreement between the City of San Diego

and the Allied Gardens Community Events (Agreement) in an amount not to exceed \$5,000 for

the project described in this resolution, under terms and conditions set forth in the Agreement on

file in the Office of the City Clerk as Document No. RR- 312423

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$5,000 from Council District 7: Fund No. 200205, Cost Center

1414111218 GL 512059, to provide funds for the above-referenced Agreement, contingent upon

the Chief Financial Officer first furnishing one or more certificates certifying that the funds

necessary for expenditure are, or will be, on deposit with the City Treasurer.
