A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS TO THE
MOBILITY BOARD COMMITTEE.

WHEREAS, modes of transportation in the City of San Diego (City) have evolved dramatically in the past decade, with critical issues emerging within the City's transportation network and a need to better coordinate different transportation decisions; and

WHEREAS, the City recently created a new Charter section 43(a) citizens' advisory board known as the Mobility Board to advise the Mayor and Council on the City's transportation network; and

WHEREAS, the Mobility Board will analyze transportation decision-making in a holistic way to help the City ensure that people driving, walking, bicycling, taking transit, parking, or using other transportation modes will have safe, easy-to-use choices to move around the City; and

WHEREAS, the Mobility Board will help ensure the development of the City's transportation network meets the City's Climate Action Plan goals; and

WHEREAS, the Mobility Board is composed of 13 appointed volunteer members serving two-year staggered terms; and

WHEREAS, the terms of no more than seven members shall expire in the same year, and members will serve until a new member is duly appointed and confirmed; and

WHEREAS, members of the Mobility Board shall possess expertise in one or more of the following areas: transportation and transit planning, bicycle and pedestrian safety, city planning,

the Americans with Disabilities Act (ADA), construction management, environmental sustainability, and public health; and

WHEREAS, one of the 13 members must have expertise in or demonstrated knowledge of the ADA and accommodation issues; and

WHEREAS, the Mayor now seeks to appoint 11 of the 13 members of the board, subject to Council confirmation; and


WHEREAS, the terms presented are staggered, as these are the initial appointments to the board; NOW, THEREFORE,


