A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO THE CONTRACT WITH LUTH AND TURLEY, INC., FOR AS-NEEDED WATER AND SEWER CLEAN-UP AND REMEDIATION SERVICES.

WHEREAS, on June 14, 2018, the Mayor and San Diego City Council authorized the City of San Diego (City) to enter into an agreement with Luth and Turley Inc. for as-needed remediation and clean-up services resulting from water main breaks and sewer backups pursuant to City Council Resolution R-311797; and

WHEREAS, additional funding of \$5,000,000 is needed during the first year of the contract, as a result of significant losses caused by recent water main breaks, including those that occurred at Larga Circle, Oregon Street, and Beardsley Street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an amendment to the contract with Luth and Turley, Inc. for as-needed remediation and clean-up services resulting from water main breaks and sewer backups, under the terms and conditions set forth in the First Amendment, on file in the Office of the City Clerk as Document No. RR-312445.
- 2. That the Chief Financial Officer is authorized to expend an additional amount not-to-exceed \$5,000,000 from Fund 700011, Water Utility Operations Fund, for services provided under the contract with Luth and Turley, provided that the Chief Financial Officer first furnishes one or more certificates demonstrating that the funds for this expenditure, are, or will be, on

deposit with the City Treasury, and provided that the final allocation of the \$5,000,000 between Water and Sewer Funds reflects the proportionate share of damages caused by water main breaks and sewer backups, respectively.
